Required Documents

1. Passport and a copy of passport photo page

- Passport with validity not less than 6 months
- At least 2 blank pages left
- One copy of passport photo page

2. Visa Application Form

- One Visa Application Form completely filled out and signed as the same as the applicant's passport signature
 (downloadable at <https://site.thaiembassy.jp/upload/pdf/about-visa-visaN.pdf>)

3. One Photograph

- Size 3.5 cm × 4.5 cm
- Colour photograph taken within the last 3 months
- Attach the photograph to the Visa Application Form
- Note that the number of photographs required depending on the applicant's nationality, please check the Additional Required Documents for Non-Japanese Applicants below

4. Personal History

- One Personal History completely filled out and signed as the same as the applicant's passport signature
(downloadable at <https://site.thaiembassy.jp/upload/pdf/about-visa-personalhistory.pdf>)

5. One copy of medical certificate / medical document issued by healthcare provider / doctor / medical institution in Thailand

- Must be written in English language
- Must have the letter head from medical institution in Thailand with doctor's signature
- Must have the seal of medical institution in Thailand
- Must contain the applicant's name / medical condition / necessity of transfer / reason to receive the medical treatment in Thailand / length of stay

6. One original medical certificate / medical document issued by healthcare provider / doctor / medical institution in Japan

- Must be an original document written in English language (PDF or fax copy is not acceptable)
- Must have the letter head from medical institution in Japan with doctor's signature (electronic signature is not acceptable)
- Must have the seal of medical institution in Japan or signature stamp of responsible doctor
- Must contain the applicant's name / medical condition / necessity of transfer / reason to receive the medical treatment in Thailand / length of stay

7. One copy of confirmed airline ticket paid in full or ticket reservation confirmation

- The confirmed airline ticket paid in full or ticket reservation confirmation must be issued by airline or travel company and must contain the applicant's name, flight number and date arrival

8. One original bank statement of the applicant in English language

- The bank statement must be original and prove a sufficient fund during the stay in Thailand
- Copy of bank book is not acceptable

9. One original Guarantee Letter

- One original guarantee letter must be presented, together with a copy of guarantor's passport or driving license duly signed by the guarantor

Guarantee Letter (downloadable at <https://site.thaiembassy.jp/upload/iblock/4ef/guarantee.pdf>)

- A guarantor must be 20 years of age or older, must be able to confirm the applicant's personal attributes. A guarantor must be available to be contacted by the Embassy and must not be a person who will accompany the applicant to Thailand
- A guarantor who are not Japanese national must provide a copy of passport and residence card (legally residing in Japan with permanent residence)
- In the English Guarantee Letter, a guarantor must sign as the same as the guarantor's identification document signature
- Japanese guarantor who prefers to use driver license, please sign as the same as signature in the guarantor letter on the copy of driver license

Additional Required Documents for Non-Japanese Applicants

10. One copy of residence card or certificate of alien registration

(On the applying date, please present the original document of identification)

- Valid for at least 3 months
- For those who are currently applying for renewal of residence card, please submit a copy of acceptance of renewal issued by the Immigration Bureau of Japan

11. Additional Photograph(s) (Only for the applicant from the listed countries below)

- Applicant with nationality of No. 1-28, please provide 3 photographs
- Applicant with nationality of No. 29-30, please provide 4 photographs
